#### **AMENDMENT NO. 2**

This Amendment No. 2 to Lease L-0058 (the "Amendment"), dated for reference purposes only, February 17, 2021, is by and between the State of California at the direction and with the consent of the Department of Forestry and Fire Protection (CAL FIRE), acting by and through its Director of General Services (DGS), hereinafter collectively referred to as State, and County of Monterey, hereinafter referred to as Lessee. State and Lessee may also be referred to as "Party" or "Parties".

#### RECITALS

WHEREAS, the State and Lessee entered into that certain Communications Vault Lease, L-0058, dated June 16, 2014 (the "Lease"), which was amended January 21, 2016 (Amendment No. One), whereby Lessee leases from the State certain premises located at Calandra Lookout, hereinafter referred to as "Calandra LO", in the County of Monterey; and

WHEREAS, Lessee currently occupies 4 and one-half (4½) communications vault rack spaces together with eight (8) antenna positions; and

**WHEREAS**, the parties hereto desire to amend said Lease for Lessee's request for modifications to its telecommunications equipment as described in that certain Radio Vault Space Application (TD-312) to add four (4) new YAGI antennas and one (1) new GPS antenna.

**NOW, THEREFORE**, it is mutually agreed between the parties hereto, that effective June 15, 2019 the Lease shall be amended as follows:

- 1. PARAGRAPH 2 (a), "USE" OF THE LEASE, shall be deleted in its entirety and replaced with the following:
- (a) The Premises shall be used during the term hereof solely and only for the purpose of installing, operating and maintaining telecommunications equipment as described in Lessee's "Radio Vault Space Application" (State Form TD-312) dated March 12, 2018 and approved by the California Office of Emergency Services (CAL OES), Public Safety Communications (PSC), effective June 11, 2019. Said "Radio Vault Space Application" complete with attachments and approval documentation by CAL OES-PSC are made a part hereof, marked Exhibit "B-2," consisting of thirty-eight (38) pages and attached as a part of this Lease. Lessee shall occupy 4 ½ vault spaces (#'s 11, 12, 13, ½ of 14 and 21) along with 13 antenna positions (#'s 8, 12, 13, 14, 21, 41, 42, 43, 44, 46, 47, 48 and 49).

 PARAGRAPH 4, "LEASE PAYMENTS" - "RENT SCHEDULE" OF THE LEASE, shall be deleted in its entirety and replaced with the following to account for new equipment installed on June 15, 2019.
