

**AMENDMENT NO. 1  
TO  
STANDARD AGREEMENT  
BETWEEN  
COUNTY OF MONTEREY  
AND  
TARPY'S ROADHOUSE, LLC dba  
COASTAL ROOTS EVENTS & CATERING**

**THIS AMENDMENT NO. 1 (Amendment)** is made to the Standard Agreement between the County of Monterey, a political subdivision of the State of California ("County") and Tarp's Roadhouse, LLC dba Coastal Roots Events & Catering. (hereinafter, "Contractor") (collectively, the "Parties") and is effective as of the last date opposite the respective signatures below.

**WHEREAS**, the Parties entered into a Standard Agreement on April 25, 2023 (the "Agreement") to allow Contractor to provide catering services at Laguna Seca Recreation Area and WeatherTech® Raceway at Laguna Seca (the "Services"); and

**WHEREAS**, the Parties wish to amend the Agreement to extend the Agreement Term and increase the not to exceed sum; and

**NOW, THEREFORE**, the Parties agree to amend the Agreement as follows:

1. Section 2, "Payment Provisions" is deleted in its entirety and replaced with  
  
"County shall pay CONTRACTOR in accordance with the payment provisions set forth in Exhibit A, subject to the limitations set forth in this Agreement. The total amount payable by County to CONTRACTOR under this Agreement shall not exceed the sum of \$360,000.00".
2. Section 3, "Term of Agreement, sub-section 3.01" is deleted in its entirety and replaced with:  
"The term of this Agreement is from May 1, 2023 to March 31, 2024, unless sooner terminated pursuant to the terms of this Agreement. This Agreement is of no force or effect until signed by both Contractor and County with the County signing last, and Contractor may not commence work before County signs this Agreement".
3. Except as provided herein, all remaining terms, conditions and provisions of the Agreement are unchanged and unaffected by this Amendment No. 1 and shall continue in full force and effect as set forth in the Agreement.
4. This Amendment No. 1 shall be attached to the Agreement and incorporated therein as if fully set forth in the Agreement.
