Resolution No. 24-

- a. Authorize reallocating \$3,071,120 of General Fund Strategic Reserves to provide advance funding to the Public Works, Facilities and Parks Department (PWFP) to complete the Fiscal Year (FY) 2022-23 Winter Storm Repair Projects in Facilities (\$2,951,152) and Parks (\$119,968) to be repaid with reimbursements from the Federal Emergency Management Agency (FEMA) and other state and federal agencies;
- b. Authorize the County Administrative Office (CAO) and Auditor-Controller to make fund balance designations in FY 2023-24 included in Attachment A (4/5th vote required); and
- c. Authorize and direct the Auditor-Controller to amend the FY 2023-24 adopted budget by increasing appropriations and estimated revenues and making the appropriate transfers included in Attachment A (4/5th vote required).

WHEREAS, California experienced winter atmospheric river events beginning on December 26, 2022 and continued into January of 2023, damaging vital infrastructure and facilities in the County of Monterey and other agencies. On January 10, 2023, the Board of Supervisors ratified a Proclamation of a Local Emergency issued by the County Administrative Officer on January 4, 2023; and

WHEREAS, the Board approved using \$21,752,475 from the Strategic Reserve on February 14, 2023 for advanced funding of winter storm repair projects; \$14,752,475 for PWFP and \$7,000,000 for Water Resource Agency (WRA); and

WHEREAS, further winter atmospheric river events continued through California beginning on March 9, 2023 and continued into mid-March 2023 exacerbating the damages from December/January and causing new damages. Furthermore, the Pajaro River Levee failed on or about March 10, 2023, causing interior flooding of the homes and businesses in the unincorporated community of Pajaro and surrounding homes and agricultural properties. A Local Emergency was proclaimed by the CAO on March 9, 2023, and ratified by the Board on March 14, 2023; and

WHEREAS, the Board approved using Strategic Reserves of \$20,131,960 for PWFP on May 23, 2023 for advance funding to complete these repairs; and

WHEREAS, projects not completed by the end of FY 2022-23 carried forward into the current FY 2023-24. Staff requests the Board authorize budget amendments and fund balance designations to fund the completion of winter storm repair projects as identified in Attachment A.

The proposed action does not increase the overall allocation of Strategic Reserves authorized by the Board on February 14, 2023 and May 23, 2023.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Supervisors of the County of Monterey, as follows:
