

In response to Contractor Requests for Information (RFI), building envelope design engineering subconsultant made additional trips to the site to perform limited invasive demolition of stuccoto-window joints, each resulting in further recommendations by the sub-consultants. Following assessment and recommendation from sub, WRD performs design revision to include the removal and replacement of approximately 50 storefront-type windows.

The December 2020 design was categorized into multiple construction options, each option being fully assessed and evaluated and rank-ordered, including development of full narratives and full cost estimating of the options and hybrid options. The rank-ordering exercise spanned several months. A determination resulted in a decision to proceed with the current scope of work including demolition of stucco on all four building elevations, and replacing flashing at wall penetrations, cement plaster accessories and control joints.
