## RENEWAL AND AMENDMENT NO. 1 TO AGREEMENT BY AND BETWEEN COUNTY OF MONTEREY AND GO KIDS, INC.

**THIS RENEWAL AN AMENDMENT NO. 1** is made by and between the County of Monterey, a political subdivision of the State of California (hereinafter referred to as "COUNTY"), and Go Kids, Inc. (hereinafter referred to as "CONTRACTOR") with respect to the following.

WHEREAS, on September 29, 2017, COUNTY and CONTRACTOR entered into AGREEMENT in the amount of \$75,000 for the term October 1, 2017, through September 30, 2020, for the provision of assisting in the proper and efficient administration of the Medi-Cal program by improving the availability and accessibility of Medi-Cal services to eligible and potential eligible individuals through the CMAA program; and

WHEREAS, the AGREEMENT expired by its terms on September 30, 2020; and

WHEREAS, the COUNTY and CONTRACTOR mutually desire to reinstate the AGREEMENT with effect retroactive to October 1, 2020; and

WHEREAS, COUNTY and CONTRACTOR wish to renew and amend the AGREEMENT retroactively to October 1, 2020 to increase the AGREEMENT \$204,000 for a total Agreement amount of \$279,000, to extend the term of the AGREEMENT by five (5) years and eight months retroactive to October 1, 2020 through June 30, 2026, with no change in the Scope of Services.

## **NOW THEREFORE**, the COUNTY and CONTRACTOR hereby agree as follows:

- 1. The AGREEMENT shall be, and hereby is, retroactively reinstated in its entirety as of October 1, 2020, and shall be considered to have been, at all relevant times as provided herein, in full force and effect as if the same had never expired.
- 2. The total amount payable by COUNTY to CONTRACTOR under this AGREEMENT is not to exceed the sum of \$279,000.
- 3. The full revised term of this AGREEMENT is from October 1, 2017 through June 30, 2026.
- 4. Except as provided herein, all remaining terms, conditions, and provisions of the AGREEMENT are unchanged and unaffected by this RENEWAL AND AMENDMENT No. 1 and shall continue in full force and effect as set forth in the AGREEMENT.
- 5. A copy of this RENEWAL AND AMENDMENT No. 1 shall be attached to the original AGREEMENT executed by COUNTY on September 29, 2017.
