AMENDMENT #1 TO AGREEMENT FOR SPECIALIZED ATTORNEY SERVICES BY AND BETWEEN COUNTY OF MONTEREY & LAW OFFICES OF KELLY S. WACHS

THIS AMENDMENT is made to the AGREEMENT FOR SPECIALIZED ATTORNEY SERVICES ("AGREEMENT") for the provision of employment-based immigration legal services by and between LAW OFFICES OF KELLY S. WACHS, a California professional corporation, hereinafter "ATTORNEY", and the County of Monterey, a political subdivision of the State of California, hereinafter referred to as "County".

WHEREAS, the County and CONTRACTOR entered into the AGREEMENT on April 10, 2021; and

WHEREAS, the County and CONTRACTOR wish to amend the AGREEMENT to increase the amount payable by \$110,000 for a total Agreement amount of \$210,000.

NOW THEREFORE, the County and CONTRACTOR hereby agree to amend the AGREEMENT in the following manner:

1. <u>Paragraph 3.02</u>. Paragraph 3.02, Budget, shall be amended and restated in its entirety as follows:

"3.02. <u>Budget</u>. ATTORNEY and COUNTY agree that the budget for services pursuant to this Agreement shall not exceed the sum of \$210,000. ATTORNEY and COUNTY shall revise the budget as necessary to reflect additional fees and expenses required for services, and this Agreement shall be amended accordingly to provide for such budget increases. Proposed budget increases must be approved by COUNTY before increased charges or expenditures are accrued. ATTORNEY shall notify the County Counsel in writing when fifty percent (50%) and seventy-five percent (75%) of the Budget has been spent. If COUNTY does not approve additional fees and expenses required by the project beyond the initial and revised budget, COUNTY hereby consents to ATTORNEY's withdrawal as co-counsel in any cases."

- 2. This AMENDMENT shall be effective as of the date of execution by both parties, with COUNTY signing last.
- 3. Except as provided herein, all remaining terms, conditions and provisions of the AGREEMENT are unchanged and unaffected by this AMENDMENT and shall continue in full force and effect as set forth in the AGREEMENT.
- 4. A copy of this AMENDMENT shall be attached to the parties' original AGREEMENT.
