

**AMENDMENT NO. 2  
TO STANDARD AGREEMENT  
COUNTY OF MONTEREY  
AND  
BLUE STRIKE ENVIRONMENTAL**

**THIS AMENDMENT NO. 2 (Amendment)** is made to the Standard Agreement between the County of Monterey, a political subdivision of the State of California (“County”) and Blue Strike Environmental (“Contractor”) (collectively, the “Parties”) and effective as of the last date opposite the respective signatures below.

**WHEREAS**, the Parties entered into a **Standard Agreement** on June 26, 2019 (the “Agreement”) to allow Contractor to provide garbage pick-up and services (the “Services”) at WeatherTech Raceway at Laguna Seca; and

**WHEREAS**, the County and Contractor executed Amendment No. 1 to the Agreement on June 18, 2021 to add food waste services and provide a 10’ x 20’ space to Contractor, at no charge, for a storage connex.

**WHEREAS**, the Parties wish to further amend the Agreement to reflect an amendment to Exhibit B-1 “Pricing Sheet” to the County of Monterey Standard Agreement Blue Strike Environmental; and

**NOW, THEREFORE**, the Parties agree to amend the Agreement as follows:

1. Exhibit B-1, “Pricing Sheet” is deleted in its entirety and replaced with Exhibit B-2, attached.
2. Except as provided herein, all remaining terms, conditions and provisions of the Agreement are unchanged and unaffected by this Amendment No. 2 and shall continue in full force and effect as set forth in the Agreement.
3. This Amendment No. 2 shall be attached to the Agreement and incorporated therein as if fully set forth in the Agreement.

- A.1 CONTRACTOR shall provide additional trash/recycling services as requested for new events not listed above. At COUNTY'S request, CONTRACTOR to provide a quote based on event capacity, number of days, and the number of teams to be located in the paddock. COUNTY will provide CONTRACTOR with an approved purchase order for services to be provided for each new event.
- A.2 CONTRACTOR shall provide trash/recycling services to any third-party Facility User, such as Sea Otter Classic, should the third-party request services. CONTRACTOR to charge third-party Facility User directly, based on the agreed upon COUNTY contract fees.
