- To advocate for women on matters:
- affordable and quality childcare, education, housing, health, equal pay, sexual harassment, community services, and related areas
- Commissioners strive to fulfill this mission through planning, organizing and advocacy, capitalizing on a diversity of knowledge, backgrounds, and experiences


## Outstanding Women Event

- In the 1980s, the Monterey County Commission on the Status of Women began formally honoring women volunteers with the Outstanding Women Event (OWE).
- Nearly 300 Women in our community have been recognized for their extraordinary work and volunteer spirit.

## Pandemic Effect

- Women faced an elevated risk of long COVID which significantly impacted their workforce participation, longterm economic health, and ability to build wealth over time.
- Women of Color were the first to lose jobs and last to regain them, causing long-term financial stress to their households.
- Women were in despair due to lack of child care while performing full-time duties both at work and home.


## Pandemic Safety Net Programs

- Pandemic response through government safety-net programs supported women to meet life's basic needs, pay down debt, and significantly reduce child poverty, highlighting a clear path forward to an equitable economy that has now been demonstrated to be feasible.
- Gender is a substantive element of the health of the state's overall workforce and capacity for economic growth and must be considered as an essential element in State resource stewardship.


## Survey Results

Most English surveys were completed by Caucasian females ages 18-65 in districts 1 \& 5

- $57.9 \%$ do not have enough to cover their bills;
- 66.3\% have 1-2 children;
- 67.3\% own a home;
- 64.2\% have no dependents;
- Seniors Top Concerns
- Long Term Care, Health Care, and Aging in Place

Most Spanish surveys were completed by Hispanic/Latinx females ages 18-65 in districts 1 \& 3

- 60.6 \% do not have enough to cover their bills;
- 51.5 \% have 3-5 children;
- 75.8 \% rent ;
- 51.5 have dependents;
- Seniors Top Concerns
- Transportation and Food
