Adopt a resolution honoring **Fernando R. Elizondo, EdD**, upon completing his 10-year term as a member of the Natividad Board of Trustees and his lifetime of service for the people of Monterey County.

WHEREAS, Dr. Fernando Elizondo was appointed to the Natividad Board of Trustees in 2013 and has served with distinction as Vice Chairperson and twice as Chairperson; and

WHEREAS, Dr. Fernando Elizondo has been instrumental in providing oversight of Natividad's mission of providing high-quality health care for Monterey County; and

WHEREAS, Dr. Fernando Elizondo received his doctorate in education from the University of Southern California, a master's degree from Baylor University and a bachelor's degree from Humboldt State University; and

WHEREAS, Dr. Fernando Elizondo has 38 years of education experience as a classroom teacher, school site principal, central office administrator, and served for 14 years as a Superintendent of Schools, including eight years at Salinas Union High School District; and

WHEREAS, Dr. Fernando Elizondo is currently owner of Elizondo Educational Strategies, an all-inclusive consulting firm specializing in working with school boards in the implementation of strategic planning and executive searches; and

**WHEREAS, Dr. Fernando Elizondo** served the Monterey County community as a member of the Board of Directors for the Monterey County Read to Me Project, which helps underserved children achieve kindergarten readiness and a lifetime of literacy; and

WHEREAS, Dr. Fernando Elizondo served as a Commissioner on the Monterey County Community Action Commission, which is committed to reducing poverty in our community by funding a network of local providers who specialize in addressing specific barriers to achieving selfsufficiency; and

**WHEREAS, Dr. Fernando Elizondo** served the community of Marina as a member of the Marina Redevelopment Agency Successor Oversight Board; and

**WHEREAS, Dr. Fernando Elizondo** served as a juror and foreperson of the County of Monterey Civil Grand Jury; and

WHEREAS, Dr. Fernando Elizondo was a pioneer in championing bilingual education in California as a founding member and Executive Director of the California Association of Latino Superintendents and Administrators where he mentored younger administrators to carry on the mantle;

WHEREAS, Dr. Fernando Elizondo previously served on the American Association of School Administrators Governing Board and on the Board of Directors for the Association of California School Administrators; and

WHEREAS, Dr. Fernando Elizondo is a docent involved in school outreach with the Point Lobos State Natural Reserve where he leads guided trail walks and coordinates elementary and high school trips to the park; and
