

**AMENDMENT NO. 2
TO SERVICES AGREEMENT
BETWEEN RJP & ASSOCIATES AND
THE COUNTY OF MONTEREY ON BEHALF OF NATIVIDAD MEDICAL CENTER
FOR
REVENUE CYCLE OPTIMIZATION CONSULTING SERVICES**

This Amendment No. 2 to the Services Agreement (“Agreement”) which was effective on July 1, 2020 is entered into by and between the County of Monterey, on behalf of Natividad Medical Center (“NMC”), and RJP & Associates (“CONTRACTOR”); **From this point forward, the party referenced previously as “NMC” shall be referenced as “COUNTY” and collectively, COUNTY and CONTRACTOR are referred to as the “Parties” to this Agreement, with respect to the following:**

RECITALS

WHEREAS, the Agreement was executed for revenue cycle optimization consulting services with a term of July 1, 2020 through June 30, 2022 and a total Agreement amount not to exceed \$280,000; and

WHEREAS, COUNTY and CONTRACTOR amended the Agreement on June 22, 2022 via Amendment No. 1 to extend the term for an additional (2) two year period through June 30, 2024 and to add an additional \$250,000, thereby increasing the total amount not to exceed \$530,000; and

WHEREAS, COUNTY and CONTRACTOR currently wish to amend the Agreement with no change to the term (July 1, 2020 through June 30, 2024), to allow for services to continue with no additions to the original scope of work, and with a \$15,000 increase to the amount payable for a total Agreement amount not to exceed \$545,000.

AGREEMENT

NOW, THEREFORE, the Parties agree to amend the Agreement as follows:

The Agreement is hereby renewed on the terms and conditions as set forth in the Original Agreement, Amendment No .1 and in Amendment No. 2 incorporated herein by this reference, except as specifically set forth below.

1. Section 2 / Paragraph titled, “PAYMENTS BY COUNTY” shall be amended to the following:
“COUNTY shall pay the CONTRACTOR in accordance with the payment provisions set forth in Exhibit-A, subject to the limitations set forth in this Agreement. The total amount payable by COUNTY to CONTRACTOR under this Agreement shall not exceed the sum of \$545,000.”
2. Except as provided herein, all remaining terms, conditions and provisions of the Agreement are unchanged and unaffected by this Amendment No. 2 and shall continue in full force and effect as set forth in the Agreement and Amendment No. 1.
3. A copy of this Amendment No. 2 shall be attached to the Agreement.
4. This Amendment No. 2 shall be effective when signed by both parties.

IN WITNESS WHEREOF, the Parties hereto are in agreement with this Amendment No. 2 on the basis set forth in this document and have executed this Amendment No. 2 on the day and year set forth herein.
