

**AMENDMENT #1 TO PROFESSIONAL SERVICES AGREEMENT
BETWEEN ENVISIONWARE INC. AND
THE COUNTY OF MONTEREY
(Amendment #1 – First Extended Term – July 1, 2022 to February 28,
2026)**

This Amendment #1 is made and entered into by and between the County of Monterey, a political subdivision of the State of California (hereinafter, “COUNTY”), and ENVISIONWARE INC. (hereinafter, “CONTRACTOR”).

WHEREAS, The County and CONTRACTOR executed and Agreement dated June 6, 2022 (hereinafter “AGREEMENT”) for the provision of services; and

WHEREAS, the County and CONTRACTOR wish to amend the AGREEMENT to extend the term end date; and,

WHEREAS, the County and CONTRACTOR wish to amend the AGREEMENT to increase the amount of the AGREEMENT to cover the additional services rendered for the term extension yet bill at the same rates set forth in the AGREEMENT; and,

NOW THEREFORE, the County and CONTRACTOR hereby agree to amend the AGREEMENT in the following manner:

1. Amend Section 2 “PAYMENTS BY COUNTY” by removing “The total amount payable by County to CONTRACTOR under this Agreement shall not exceed the sum of **\$130,000.00.**” and replacing it with “The total amount payable by County to CONTRACTOR under this Agreement shall not exceed the sum of **\$188,123.35.**”
2. Amend Section 3.01 “TERM OF AGREEMENT” by removing “The term of this Agreement is from **July 1, 2022 to June 30, 2025.**” and replacing it with “The term of this Agreement is from **July 1, 2022 to February 28, 2026.**”
3. If there is any conflict or inconsistency between the provisions of the Agreement or its amendments, the following shall have precedence:
 - This Amendment #1 over the Agreement.
4. The recitals of this Amendment #1 are incorporated into the Agreement and this Amendment #1.
5. Except as provided herein, all remaining terms, conditions and provisions of the AGREEMENT, including Limitation of Liability are unchanged and unaffected by this AMENDMENT #1 and shall continue in full force and effect as set forth in the AGREEMENT.
6. A copy of this Amendment # 1 shall be attached to the original Agreement dated 6/21/22.
