Delete the above language and replace with the following:



The payment of \$195,501.00 will complete the full compensation of \$325,308.35 for the PG&E Utility Relocation work by PG&E for the Nacimiento Lake Drive Bridge project (County Project No. 2202; PG&E project No. PM#35161303 & 35182064).


