

**AMENDMENT #1 TO AGREEMENT
COUNTY OF MONTEREY AND
BLUE STRIKE ENVIRONMENTAL**

THIS AMENDMENT #1 is made to the AGREEMENT (Agreement ID: 7/1/19 – 6/30/24) for the provision of garbage pick-up and services for WeatherTech Raceway Laguna Seca in the **County of Monterey Standard Agreement** by and between **BLUE STRIKE ENVIRONMENTAL**, hereinafter “CONTRACTOR”, and the County of Monterey, a political subdivision of the State of California, hereinafter referred to as “County”; and

WHEREAS, the County executed the original AGREEMENT on June 26, 2019; and

WHEREAS, the County and CONTRACTOR wish to amend the AGREEMENT to reflect an amendment to Exhibit A “Scope of Services” and Exhibit B “Pricing Sheet” to the County of Monterey Standard Agreement Blue Strike Environmental.

NOW THEREFORE, the County and CONTRACTOR hereby agree to amend the AGREEMENT in the following manner:

- 1. Exhibit A, “Scope of Services” shall be amended to include the following:

Exhibit A, Section 5.7 shall be added as follows –

CONTRACTOR shall provide food waste services if there is any type of cooking onsite. Food waste to be removed from receptacles in the Paddock and Lakebed areas, refresh receptacles with new trash liners/bags, continually monitoring throughout the entire day of the event. CONTRACTOR shall place food waste from smaller receptacles to large collection bins located elsewhere on property. CONTRACTOR shall not charge COUNTY any additional fee for this service.

Exhibit A, Section 5.8 shall be added as follows –

Upon CONTRACTOR’S request, COUNTY shall provide a 10’ x 20’ space to CONTRACTOR, at no charge, for a storage connex. Said storage connex to be used for the storage of items related to Laguna Seca Recreation Area / WeatherTech Raceway Laguna Seca only. Any cost associated for the storage connex will be at CONTRACTOR’S sole expense.

- 2. Exhibit B, “Pricing Sheet” shall be deleted in its entirety and replaced with Exhibit B-1 attached.
- 3. Except as provided herein, all remaining terms, conditions and provisions of the AGREEMENT are unchanged and unaffected by this AMENDMENT and shall continue in full force and effect as set forth in the AGREEMENT.
- 4. A copy of the AMENDMENT #1 shall be attached to the original AGREEMENT signed June 26, 2019.

- A.1 CONTRACTOR shall provide additional trash / recycling services as requested for new events not listed above. At COUNTY'S request, CONTRACTOR to provide a quote based on event capacity, number of days, and the number of teams to be located in the paddock. COUNTY will provide CONTRACTOR with an approved purchase order for services to be provided for each new event.
- A.2 CONTRACTOR to provide trash / recycling services to any third-party Facility User, such as Sea Otter Classic, should the third-party request services. CONTRACTOR to charge third-party Facility User directly, based on the agreed upon COUNTY contract fees.
