Pursuant to Article 2 of the California Public Utilities Commission’s Rules of Practice and Procedure, Pacific Bell Telephone Company d/b/a AT&T California (U 1001 C)¹ respectfully submits this Application to relinquish its designation under federal law as an Eligible Telecommunications Carrier (“ETC”) in California, effective December 1, 2023.² By this filing, AT&T California is not discontinuing any tariffed voice service, and the ETC relinquishment will not affect the availability of tariffed voice service in AT&T’s service territory.³

I. INTRODUCTION AND BACKGROUND

Since 1997, AT&T California has been an ETC pursuant to 47 U.S.C. § 214(e).⁴ As a designated ETC, it is eligible to receive federal universal service funding pursuant to conditions set forth in 47 U.S.C. § 254. Such funding has historically included (1) “high cost” support to maintain affordable voice service in its service territory and to deploy and maintain networks in rural and other high-cost areas and (2) reimbursement from the federal Lifeline Assistance Program for providing local voice telecommunications services to eligible low-income consumers at discounted prices. Historically, AT&T California received high-cost universal service support, and it has used the associated funds to maintain affordable telephone service and, later, with the onset of federal high-cost support for broadband, to expand the geographic

reach of its broadband services in the State. As an ETC, AT&T California has also offered federally-supported low income (“Lifeline”) universal service benefits in California.

For the past several years, however, the Federal Communications Commission (“FCC”) has refocused these traditional universal service support programs, steadily reducing the scope of AT&T California’s participation. AT&T California receives no federal high-cost universal service support and thus no longer requires an ETC designation to be eligible for the receipt of such support anywhere within its California service territory.⁵

Because AT&T California no longer receives federal high-cost universal service support, AT&T California should no longer have the obligations of a federal ETC, including the obligation to participate in the federal Lifeline program. Further, relinquishment of ETC designation does not raise any significant policy concerns. AT&T California’s LifeLine subscribers have been sharply trending downward since the mid-2000s.⁶ AT&T California estimates only about 105,000 consumers obtained federal Lifeline benefits from AT&T

California as of December 2022.⁷ Customers eligible for LifeLine support now overwhelmingly choose wireless carriers over wireline incumbent local exchange carriers (“ILEC”) like AT&T California for their LifeLine benefits, just as consumers across the United States and the world today overwhelmingly choose the mobility and convenience of their wireless phones over landline phones for voice service. Of the roughly 1.17 million subscribers participating in the LifeLine program in California as of December 2022, approximately 84 percent choose wireless carriers for their LifeLine benefits.⁸

As California consumers continue to demonstrate their clear preference for wireless service, AT&T California now seeks to relinquish its ETC designation, effective December 1, 2023. That is the date when the federal Lifeline voice-only subsidy is scheduled to phase out.⁹ At that time, the FCC will finish transitioning federal Lifeline from voice to broadband and thus will no longer support the sole service for which AT&T California receives federal Lifeline support: voice-only telephone service.¹⁰ Because the relinquishment of AT&T California’s ETC designation coincides with the phase-out of the federal subsidy, it will not impact any Lifeline customer.

At the same time, AT&T California seeks to eliminate its regulatory designation as an ETC only under federal law. AT&T California will continue to offer and provide retail voice services, including tariffed voice service, as required by federal and state law in all of its service territory, unless and until it separately obtains any necessary permission to stop providing such retail services.¹¹ After relinquishment, it will still provide state LifeLine voice service, as supported by sections 874 and 875 of the Moore Universal Telephone Service Act¹² in any area where it provides basic local service.¹³ Importantly, relinquishment of AT&T California’s ETC designation will not result in the discontinuance of any service.

In addition, granting this Application will not affect AT&T California’s ongoing participation in the FCC-administered Affordable Connectivity Program (“ACP”) because that program does not require providers to be designated as ETCs to participate.¹⁴ A modern successor to legacy voice-oriented, low-income support programs, the ACP promotes broadband affordability and adoption by supporting discounts of up to \$30/month on internet services for eligible households (and up to \$75/month for tribal consumers).¹⁵ AT&T California looks forward to continued participation in that program, which has almost doubled in size in the 12

months since its December 2021 inception and had approximately 600,000 more participants than the LifeLine program in California, as of December 2022.¹⁶

II. AT&T IS ENTITLED BY LAW TO RELINQUISH ITS ETC DESIGNATION.

Congress established the conditions under which a state must allow any carrier designated as an ETC, including any incumbent local exchange carrier (“ILEC”) such as AT&T California, to relinquish its ETC designation. In particular:

A State commission ... *shall permit* an eligible telecommunications carrier to relinquish its designation as such a carrier in any area served by more than one eligible telecommunications carrier. An eligible telecommunications carrier that seeks to relinquish its eligible telecommunications carrier designation for an area served by more than one eligible telecommunications carrier shall give advance notice to the State commission ... of such relinquishment.¹⁷

AT&T California satisfies these conditions because (1) there is at least one other ETC in each wire center where AT&T California will relinquish that status, and (2) the company is providing advance notice to the Commission that it is relinquishing its ETC status.

A. At Least One Other Eligible Telecommunications Carrier Serves All Areas in Which AT&T California Will Relinquish Its ETC Designation.

Federal law entitles AT&T California to relinquish its ETC designation for each service area that is “served by more than one eligible telecommunications carrier.”¹⁸ Pursuant to that standard, every other state has in whole or in part permitted AT&T ILECs to relinquish their ETC designations, and *no state* has denied AT&T’s request for ETC relinquishment.¹⁹ AT&T California requests that this Commission grant similar relief by permitting relinquishment of its ETC designation in California.

As shown in Attachment A, there is at least one ETC in each wire center in AT&T California’s service territory. The analysis in Attachment A uses the wireline deployment data collected and made publicly available by this Commission on its website along with other industry data needed to identify the areas served by wireline and wireless ETCs in AT&T California’s service territory.²⁰ Attachment A demonstrates that there is extensive overlap in ETCs in AT&T California’s service territory by listing the ETCs that have been designated for each wire center in AT&T’s service territory.²¹ Other ETCs in California include subsidiaries of

wireless carriers T-Mobile (Assurance) and Verizon (Tracfone),²² each of which has more LifeLine subscribers in California than AT&T.²³

Where, as here, alternative ETCs are available, the Commission has permitted the relinquishment of ETC designation by numerous other carriers.²⁴ For the same reason, AT&T California is entitled to relinquish its ETC designation.

These facts by themselves fully entitle AT&T California to relinquishment of its ETC designation under controlling federal law. And while no further public interest or public safety inquiry is appropriate under the federal standard for relinquishing an ETC designation, any such inquiry would be satisfied:²⁵

- All Lifeline customers served by AT&T California can obtain Lifeline discounts from other ETCs because the areas impacted by AT&T California's ETC relinquishment are currently served by one or more other ETCs.
- No purchase or construction by other carriers will be necessary because the remaining ETCs in AT&T California's service areas are fully operational such that no further purchase or construction is needed.²⁶

- There are no safety concerns with AT&T California’s request because the company is not discontinuing service, and AT&T California’s customers can still obtain service from numerous other providers, including those participating in the federal and state Lifeline programs.

B. AT&T Has Provided Notice of Its ETC Relinquishment.

By this Application, AT&T California is discharging its obligation to provide “advance notice to the State commission ... of [its ETC] relinquishment.”²⁷ The Commission has previously recognized that such applications satisfy this requirement.²⁸ As a courtesy, AT&T California has also served this Application on the service lists associated with the LifeLine proceeding (R.20-02-008).²⁹

III. PROCEDURAL REQUIREMENTS

A. Compliance with Rule 2.1(a)

Pursuant to Rule 2.1(a) of the Commission’s Rules of Practice and Procedure, AT&T California’s full legal name is Pacific Bell Telephone Company d/b/a AT&T California. AT&T California is a corporation created under the laws of California and is located at 430 Bush Street, San Francisco, CA 94108.
