WHEREAS, Natividad Medical Center (NMC) administration staff recently conducted a classification study to determine if there is sufficient market data to help support the creation of a certified journey- and supervisory-level Health Information Management Coder classification; and

WHEREAS, the study found that there was sufficient market data available to support the creation of a certified series to include the Certified Health Information Management Coder-Inpatient and Certified Health Information Management Coding Supervisor classifications; and

WHEREAS, to establish a salary for the new classifications, NMC completed an external base wage compensation analysis and found there were four (4) matches within the County's six (6) hospital comparable agencies for the certified journey level classification and three (3) matches within the County's six (6) comparable agencies for the certified supervisory level classification; and

WHEREAS, NMC recommends the reallocation of the Health Information Management Coder II positions to Certified Health Information Management Coder-Inpatient and the Health Information Management Coding Supervisor position to Certified Health Information Management Coding Supervisor;
