Thomas, thank you for the clarification.

I have two other questions:

- Have you circulated this document with Cal Water? Cal Water provided site maps during initial project coordination. Preliminary plans (currently at CD60%) have been developed based on these maps. Final design will be submitted to Cal Water to review our proposed by-pass connection point i.e. location where a meter could be placed if we decided to switch back to Cal Water services.
- 2. Is the well you mentioned currently in use for irrigation? No. The well is in a non-operable state and does not currently have a pump. A new pump would be installed at a later date after plans have been reviewed and permitted by all jurisdictions having authority. We have plans to clean, re-line, and test capacity with a temporary pump that will be removed (basis of final design). The existing well use to service the entire park up until the 1970's.

Thanks for the opportunity to reply Bryan. You've captured the project scope accurately. I'd like to clarify that the well rehab/irrigation scope will be completed in parallel and under the same permit as the booster station upgrades which consist of replacing the monitoring/control system. The booster pump station is currently on the Cal Water potable water system and will remain that way. As you noted, there is no increase to the capacity.

Also, there is no change to the footprint of turf area being irrigated.

Yes, family is good and while the new baby girl is quite tiring, she is most definitely amazing! Thanks for

asking.

The Toro Park water and utility project is funded by the American Rescue Plan Act (ARPA) and is part of a suite of projects the County is undertaking at numerous parks and facilities. The main goal of the Toro Park project is to rehab the defunct well to get it back online so that we can stop using municipal potable water (Cal Water) to irrigate the turf areas. The well was taken offline over a decade ago due to sand intrusion and we have been on municipal water ever since with an annual cost of \$50,000 to \$100,000. The new pipeline is necessary to split the irrigation off of the potable water system. The pipeline will go from the well site at the front of the park to Quail Meadows at the back of the park. The booster station upgrades are not part of the irrigation/well project. The booster station pushes potable water uphill to the Youth Overnight Area and the Environmental Center/Volunteer campground and is in need of some minor work to make it work more reliably and efficiently, not to increase capacity.

I've copied Thomas Montoya who is managing the project for Parks in case he has any additional information.

Thank you for providing the Monterey Bay Air Resources District (Air District) with the opportunity to comment on the Mitigated Negative Declaration for the Toro Park Water System Improvement Project. The Air District has reviewed the MND and has the following comments:

Air Quality

Construction Emissions

To further reduce construction-related emissions including odors and short-term diesel particulate matter, the Air District recommends using construction equipment which conforms to the Air Resources Board's Tier 3 or Tier 4 emission standards. Where feasible, construction equipment should use alternative fuels such as compressed natural gas, propane, electricity, or biodiesel.

Fugitive Dust Control

- Fugitive dust can be mitigated while maintaining compliance with MBARD Rule 402 (Nuisance) and CEQA Guidelines, Section 8.2 by implementing the following Best Management Practices as applicable:
 - Water all active construction areas at least twice daily. Frequency should be based on the type of operation, soil, and wind exposure.
 - Prohibit all grading activities during periods of high wind (over 15 mph).
 - Cover all trucks hauling dirt, sand, or loose materials.
 - Cover inactive storage piles.
 - Maintain at least 2'0" of freeboard in haul trucks.
 - Apply chemical soil stabilizers on inactive construction areas (disturbed lands within construction projects that are unused for at least four consecutive days).

Engine Permitting

- Internal Combustion Engines: Rule 201, Section 4.14
 - If an emergency generator is needed to support the construction process or the operation of the Booster Station, a permit maybe required. Any stationary piston-type

internal combustion engine of greater than or equal to 50 brake horsepower (bhp) requires a permit. Please contact MBARD's Engineering Division if there are any questions regarding the permitting process.

Hazardous Materials

- Asbestos Piping
 - The Air District wants to ensure that if older underground asbestos (Transite) piping is encountered during trenching, the requirements of Air District Rule 424 National Emissions Standards for Hazardous Air Pollutants could be triggered. Please contact Shawn Boyle, Compliance Program Coordinator, at (831) 718-8010 or sboyle@mbard.org for more information regarding this rule.

Mr. Montoya,

California Water Service (Cal Water) supports the County of Monterey's (County) proposed project to rehabilitate the existing Toro Park Well to provide irrigated water in and to Toro Park. Previously, the well provided potable water; however, due to water quality issues, well water should only be used for irrigation. It appears that this is the intent of the County in the rehabilitation project as part of the project includes installation of a new irrigation pipeline to the Toro Park Well.

The Initial Study/Mitigated Negative Declaration (IS/MND) appears to represent that the Toro Park Well is County owned and operated. While that has been discussed with the County, the necessary transfer of the well from Cal Water to the County has yet to be effectuated. Cal Water seeks to coordinate with the County to amend the existing operation and maintenance agreement between the parties, which currently includes the existing well in Toro Park. The amendment will appropriately relinquish use and control of the well to the County. In addition to our request to amend the agreement, Cal Water will coordinate the disconnection between the existing irrigation pipes from Cal Water's potable water system, which includes disconnection from services; meters that currently provide irrigated service to the park. Cal Water is currently signed up for PG&E service that provides power to the pump motor for this well. We need to coordinate a date to transfer service to the County. These issues should likely be added to the IS/MND project description (Section II (C)).

Separately, Cal Water will continue to provide potable water service to the project site as noted under Section IV (19) of the IS/MND, page 14. Potable water is not provided from the Toro Park Well that is subject to the rehabilitation.

We look forward to working cooperatively with the County on its irrigation project going forward, including amending the existing agreement, disconnect existing irrigation services, transfer PG&E service and other ancillary tasks to bring the project to completion.

I will be the point of contact for this coordination.
