

**Amendment No. 1
To Standard Agreement
By and Between
County of Monterey and Jackson Physician Search, LLC.**

THIS AMENDMENT No. 1 is made and entered into by County of Monterey, a political subdivision of the State of California, (hereinafter referred to as “County”) and Jackson Physician Search, LLC. (hereinafter referred to as “CONTRACTOR”)

RECITALS:

WHEREAS, County and CONTRACTOR have entered into an Agreement to provide recruitment and placement of physicians, nurse practitioner, and/or physician assistant services for a term effective May 15, 2023 until May 31, 2025 and an amount not to exceed \$198,000; and

WHEREAS, the County and CONTRACTOR wish to amend the Agreement to increase the amount of the Agreement by \$332,000 for a new Agreement amount not to exceed \$530,000 as specified below.

NOW THEREFORE, the County and CONTRACTOR hereby agree to amend the Agreement, as follows:

1. Section 2.0. Section 2, PAYMENT PROVISIONS, is hereby amended and restated to read in its entirety as follows:

“2.0 PAYMENT PROVISIONS:

County shall pay the CONTRACTOR in accordance with the payment provisions set forth in Exhibit A, subject to the limitations set forth in this Agreement. The total amount payable by County to CONTRACTOR under this Agreement shall not exceed the sum of \$530,000.”

2. Except as provided herein, all remaining terms, conditions and provisions of the Agreement are unchanged and unaffected by this Amendment No. 1 and shall continue in full force and effect as set forth in the Agreement.
3. A Copy of this Amendment No. 1 shall be attached to the Agreement.
4. This Amendment No. 1 shall be effective upon execution by both parties.
