**WHEREAS**, the Board of Supervisors, acting on behalf of County Service Area No. 75-Chualar (CSA 75-Chualar), has enacted Ordinance No. 04225 which provides for the collection of sewer service charges by use of a monthly billing system;

**WHEREAS,** 21 property owners in CSA 75-Chualar were identified with past due balances totaling \$15,713, including late penalty fees, as identified in Attachment B attached;

**WHEREAS,** Ordinance No. 04225, which amends Section 16 of CSA 75-Chualar Ordinance No. 3920, allows for the collection of delinquent fees and a lien transfer fee as special assessments constituting a lien on the property;

**WHEREAS,** it is desirable that past due assessments for sanitation service be collected; and

**WHEREAS,** the Board of Supervisors, acting on behalf of CSA 75-Chualar, conducted a public hearing, heard the report, and considered any property owner protests and objections to the report to satisfy the requirements of Ordinance No. 04225 regarding procedures for collection of delinquent fees.

**NOW, THEREFORE, BE IT RESOLVED THAT** the Monterey County Board of Supervisors, acting on behalf of CSA 75-Chualar, does hereby:

- a. Confirm the report of delinquent sanitation fees for County Service Area 75-Chualar, as identified in "Report of 2023 Delinquent Fees County Service Area No. 75-Chualar"; and
- b. Authorize the delinquent fees as set forth in the confirmed "Report of 2023 Delinquent Fees County Service Area No. 75-Chualar" (Exhibit A) to constitute special assessments against the respective parcels of land to be collected at the same time and in the same manner as ordinary ad valorem property taxes are collected.
