AMENDMENT No. 1 TO NON-STANDARD AGREEMENT BY & BETWEEN COUNTY OF MONTEREY AND ACCELA, INC.

This **AMENDMENT No. 1** is made to the Non-Standard Agreement ("AGREEMENT") by and between Accela, Inc. ("CONTRACTOR"), and the County of Monterey, a political subdivision of the State of California ("COUNTY").

WHEREAS, on July 1, 2021, COUNTY and CONTRACTOR entered into the AGREEMENT for software subscription services in a vendor hosted environment for Envision Connect and Accela platform, technical support and maintenance for the period July 1, 2021, through August 31, 2024; and

WHEREAS, COUNTY and CONTRACTOR wish to amend the Agreement to 1) extend the term to August 31, 2027 and 2) add an aggregate amount of \$474,721.47 as outlined in the subscription quote attached as EXHIBIT E.

NOW THEREFORE, COUNTY and CONTRACTOR hereby agree to amend the AGREEMENT in the following manner:

- 1. Section 3 .01 of the AGREEMENT is revised to extend the August 31, 2024 termination date to August 31, 2027.
- 2. Section 2.0 of the AGREEMENT is revised, and an aggregate amount of \$474,721.47 is added as outlined in the subscription quote attached as EXHIBIT E, for a new Not-To-Exceed agreement amount of \$905,810.28.
- 3. Except as provided herein, all remaining terms, conditions and provisions of the AGREEMENT are unchanged and unaffected by this Amendment No. 1 and shall continue in full force and effect as set forth in the AGREEMENT.
- 4. A copy of this AMENDMENT No. 1 shall be attached to the original AGREEMENT dated July 1, 2021, and shall be incorporated therein as if fully set forth in the Agreement.
- 5. The recitals to this Amendment No. 1 are hereby incorporated by this reference
