**AMENDMENT NO. 1 TO
STANDARD AGREEMENT
BETWEEN MONTEREY COUNTY WATER RESOURCES AGENCY AND
RAFTELIS FINANCIAL CONSULTANTS, INC.**

THIS AMENDMENT NO. 1 to the Standard Agreement between the Monterey County Water Resources Agency, a political subdivision of the State of California (hereinafter, "Agency") and Raftelis Financial Consultants, Inc., (hereinafter, "CONTRACTOR") is hereby entered into between the County and the CONTRACTOR (collectively, the County and CONTRACTOR are referred to as the "Parties").

WHEREAS, CONTRACTOR entered into a Standard Agreement with Agency on July 17, 2017 (hereinafter, "Agreement"); and

WHEREAS, the Parties wish to amend the Agreement to add additional funds to continue providing services identified in the Agreement.

NOW, THEREFORE, the Parties agree to amend the Agreement as follows:

1. Amend Section 3, "**Payments to CONTRACTOR**"; maximum liability. Subject to the limitations set forth herein, Agency shall pay to CONTRACTOR the amounts provided in Exhibit B. The maximum payable to CONTRACTOR under this contract is:
