Supervisor Chris Lopez commented on a couple of items; first he wanted to let the public know that April 14, 2019 which will be Ciclovía in King City, they are very excited as it will be the first one down in King City; there is a Planning meeting coming up tomorrow February 13th from 6:00 to 7:30 p.m. at the King City Library, come out and join them as it will be wonderful this is going to be a partnership between the City of King, Monterey County Building Healthy Communities and some other partners that he is really excited to finally bring down to King City; lastly he got the opportunity to participate in the county libraries feedback sessions and it was very valuable; and he wanted to thank Michelle Slate and her team for putting those meetings on in and listening to our community who have very different outcomes from our King City session and the Greenfield session with great participation from communities in Soledad coming to Greenfield and folks South of King City coming to King City for those session, this was really important pieces of information that was shared, and he looks forward to seeing the final report.

Supervisor Mary L. Adams commented she is excited to host local representative, Carol Groom, on the California Coastal Commission, here in Monterey County on February 15th this Friday; the purpose of this is for Ms. Groom to learn more about Big Sur from the residents who live there; she is also pleased and wanted everyone to know that her Chief of Staff Yuri Anderson is going to be participating in the county's next Governing for Racial

Equity cohort and the cohort training starts tomorrow it's a two day intensive training in Oakland and she is very proud that Yuri is able and willing to participate in this and thanked all for their support with this.

Supervisor John M. Phillips commented they had a nice peace march which Supervisor Alejo took the lead in organizing; it was a nice event which went from Watsonville into Pajaro, a lot of the families of people who lost their young people unfortunately were there; he will let Supervisor Alejo speak more on this.

Supervisor Luis A. Alejo commented he was really honored dead or 500 a mother's and family members, community members came out on Sunday to once again hold the 25th Annual Watsonville Peace and Union March that started in 1994 shortly after the tragic deaths of a 9 year old little girl and her sixteen-year-old brother, this year's march was led by their mother Maria Salazar Cortez who now lives in Salinas and her daughter Adreana Salazar who works for Monterey County Behavioral Health and then also a mother who has been there every single year Rosa Deramirez she lost 19 her old son; it was really moving for the mothers to have so much community support and we thank God for a beautiful day the weather cleared up luckily on Sunday for that period of time it was a really nice ceremony we walked and renamed a small County property and named it the Jessica and George Cortez the two children and they planted a memorial tree and our bench got separated they had some missing parts but luckily this Friday at 3:30 we're going to be installing the memorial bench which was raised with private money from him and from Supervisor Phillips to install that bench for the people of Pajaro they are right off Salinas Road as you approach a Sumption church; he wanted to thank everybody who came out and it was it was attended by the Supervisor Chris Lopez, Supervisor Phillips, former Supervisor Simon Salinas, Congress member Jimmy Panetta and numerous other local officials in Watsonville and wanted to thank the local press KSBW, KION, The Pajaronian, Univision, Telemundo who all made stories to promote the march in advance or the day so for those that could not attend at least through the local media the public was able to know that here in the community that's right on the borderline of Monterey and Santa Cruz County they are doing something and they have done it for a very long time and it's the only peace march of it's kind in the entire State of California that is been done and organized continuously now for 25 years; he wanted to thank all the organizers and the mothers for their courage and for bringing the community once together; he did want to lastly end and say that the mothers from Salinas came and joined the mothers of Watsonville there were some others from King City and Santa Cruz that also came so that day everybody came together as one community and it was a beautiful thing to see the mothers support each other in that way after sharing their similar struggles of losing their own children to gang or domestic violence.

Supervisor Jane Parker shared a reminder that tomorrow evening is the Seaside Town Hall meeting on homeless shelter locations it's at 6:00 p.m. at the Oldemeyer Center and is hosted by council members John Wizard and Dave Pacheco. She also acknowledged Shelly Whitworth Shipley who is the energy communication specialist with Monterey Bay Community Power; she demonstrated some above and beyond customer service being on social media on Sunday evening, and answered questions about PG&E bills and the Monterey Bay Community Power apparently the cold weather has people were

noticing their bills are higher and they're starting to notice the Monterey Bay Community Power on their on their bills so she just wanted to make sure that people know that most of us do have Monterey Bay Community Power as their electricity provider and it is providing cleaner energy 100% carbon-free that's the default that there are getting and the cost is the same as PG&E on the bill but at the end of the year they all got a 3% rebate; she thinks this coming year it's going to be at least a 4 to 5% rebate so it ends up making their electricity prices cheaper than PG&E that rebate was 4.4 million dollars that came back to the residence of the Central Coast so good for the economy as well as for the planet; she also wanted to mention you've probably seen in the paper some coverage about the Fort Ord Regional Trail FORTAG being awarded some funding through a state grant and the transportation agency for Monterey County will be constructing a one and a half mile paved trail for pedestrians and bicyclists going from Del Rey Woods Elementary School in Del Rey Oaks to the intersection of Fremont Boulevard and the 218 highway; it's going to necessitate a tunnel to be built underneath the 218 so it means right now there's no safe way for kids or local resident to get to the south side of 218 and then along to the grocery store or the drug store at Fremont Boulevard since Highway 218 is fairly narrow and has pretty high speed traffic; there's no real sidewalk or anything so the FORTAG Trail will really benefit the folks in that community to start with ultimately the trail and will extend all the way up into Marina and she wanted to say how much she appreciated the work of the CSUMB Professors Scott Waltz and Fred Watson whose vision this was they really worked closely with them to get this idea that they had through all the government agencies and the public review process and so on so it's a great benefit to region and particularly to the constituents of District 4 who want to get around on foot or on bicycle.

Supervisor Mary L. Adams also added that yesterday was the 10th Anniversary of 211 the free information referral service in Monterey County; it's an excellent program sponsored through the United Way and there was a lovely event yesterday honoring a number of people including former board member Dr. Bauman and Supervisor Phillips was able to present a resolution from our board; it is an amazing service and has provided a lot of help to more than a hundred and thirty three thousand people in the 10 years it has been going.
