

## **AMENDMENT #1 TO AGREEMENT COUNTY OF MONTEREY AND McCUNE AUDIO VIDEO LIGHTING**

**THIS AMENDMENT #1** is made to the AGREEMENT (Agreement ID: 10/15/20-6/30/21) for the provision of public announcement communication and corner worker staff direct communication for events and track rentals in the **County of Monterey Standard Agreement** by and between **McCUNE AUDIO VIDEO LIGHTING**, hereinafter “CONTRACTOR”, and the County of Monterey, a political subdivision of the State of California, hereinafter referred to as “County”; and

**WHEREAS**, the County executed the original AGREEMENT on October 22, 2020; and

**WHEREAS**, the County and CONTRACTOR wish to amend the AGREEMENT to reflect an amendment to the County of Monterey Standard Agreement McCune Audio Video Lighting and Exhibit A “Scope of Services”.

**NOW THEREFORE**, the County and CONTRACTOR hereby agree to amend the AGREEMENT in the following manner:

1. Section 2.0 “PAYMENT PROVISIONS” shall be amended by removing “**The total amount payable by County to CONTRACTOR under this Agreement shall not exceed the sum of \$60,000.00**” and replacing it with “**The total amount payable by County to CONTRACTOR under this Agreement shall not exceed the sum of \$179,000.00**”.
2. Section 3.01 “TERM OF AGREEMENT”, shall be amended by removing “**The term of this Agreement is from October 15, 2020 to June 30, 2021...**” and replacing it with “**The term of this Agreement is from October 15, 2020 to December 31, 2021...**”.
3. Exhibit-A, Article II, Section 2.11 to be amended to include the following additional full-service 2021 events at the price noted:
