Adopt a resolution honoring **Dr. Marni R. Sandoval**, Deputy Director of Behavioral Health, for her dedicated service of 24 Years and 8 Months to the Health Department's Behavioral Health Bureau of the County of Monterey.

WHEREAS, Dr. Sandoval earned a Doctorate of Psychology from the California School of Professional Psychology, a Master of Arts in Clinical Psychology from the California School of Professional Psychology, and a Bachelor of Arts in Psychology from the University of California, Davis; and

WHEREAS, Dr. Sandoval began her tenure with the County of Monterey as a Behavioral Health Unit Supervisor in August 2000 and was then promoted to Deputy Director of Behavioral Health for the Children System of Care in July 2015; and

WHEREAS, Dr. Sandoval is an experienced Behavioral Health professional with over 27 years of extensive expertise in assessing and treating neglected and traumatized children and families and over 10 years of experience administering a vast array of child & adolescent behavioral health programs; and

WHEREAS, Dr. Sandoval was instrumental in developing the Health Department Behavioral Health Bureau's doctoral psychology training program for interns and practicum students that has led to positive workforce development and hiring of doctoral-level professionals; and

WHEREAS, Dr. Sandoval spearheaded the development of the Child & Youth Mobile Response Team, a 24-hour/7-day-a-week crisis intervention for youth experiencing an immediate crisis; and

WHEREAS, Dr. Sandoval's efforts were crucial in the construction of the Crisis Stabilization Unit and the Children's Crisis Residential Program for youth ages 6 to 18, expected to be operational in the summer of 2025; and

WHEREAS, Dr. Sandoval played a pivotal role in the construction of the Alisal Integrated Health Center (AIHC) located at 331 North Sanborn Road in Salinas. The AIHC is the new home to the Mental Health Plan's child and youth behavioral health services and a small satellite primary care health clinic; and

WHEREAS, Dr. Sandoval, in her role as Deputy Director, directed an extensive array of mental health and substance abuse programs; and

WHEREAS, Dr. Sandoval has exhibited an exemplary work ethic during her tenure with the County of Monterey; and

NOW, THEREFORE, BE IT RESOLVED, That the County of Monterey Board of Supervisors on behalf of all the County workforce and residents thereof, hereby acknowledge, commend, and express its sincere appreciation to **Dr. Marni R.
