

**RENEWAL AND AMENDMENT NO. 2
TO THE SERVICES AGREEMENT
BETWEEN NATIVIDAD MEDICAL CENTER (COUNTY OF MONTEREY) AND
QUINN POWER SYSTEMS
FOR
MAINTENANCE OF GENERATORS AND AUTOMATIC TRANSFER SWITCH SERVICES**

This Renewal and Amendment No. 2 to the County of Monterey, Natividad Medical Center (NMC) Agreement for Services is made and entered into, by and between the County of Monterey (hereinafter "County"), a political subdivision of the State of California, on behalf of Natividad Medical Center, an acute care hospital (hereinafter, "NMC"), and Quinn Power Systems (hereinafter "CONTRACTOR"); **From this point forward, the party referenced previously as "NMC" shall be referenced as "COUNTY" and collectively, COUNTY and CONTRACTOR are referred to as the "Parties" to this Agreement, with respect to the following:**

RECITALS

WHEREAS, the Agreement was executed for maintenance of generators and automatic transfer switch services with a term of July 1, 2015 through June 30, 2018 and a total Agreement amount not to exceed \$184,993; and

WHEREAS, NMC and CONTRACTOR amended the Agreement to extend it for an additional three (3) year period through June 30, 2021 to allow for services to continue with a \$18,400 increase for the added services for a total Agreement amount of \$203,393.

WHEREAS, the Parties wish to renew and amend the Agreement on the same or similar terms, beginning July 1, 2021 and to extend the term for an additional one (1) year period through June 30, 2022 for a revised full Agreement term of July 1, 2015 through June 30, 2022 to allow for services to continue with no change to the total Agreement amount of \$ 203,393.

AGREEMENT


NOW THEREFORE, the Parties agree as follows:

The Agreement is hereby renewed and amended on the terms and conditions as set forth in the original Agreement, Amendment No. 1 and Renewal and Amendment No. 2 incorporated herein by this reference, except as specifically set forth below.

1. "TERM OF AGREEMENT" Section shall be amended to the following:
"The term of this Agreement is from July 1, 2015 through June, 30, 2022 unless sooner terminated pursuant to the terms of this Agreement".
2. If there is any conflict or inconsistency between the provisions of Agreement, Amendment No.1 or this Renewal and Amendment No. 2, the provisions of this Renewal and Amendment No.2 shall govern.
3. This Renewal and Amendment is effective retroactively on July 1, 2021.


