WHEREAS, the Department is requesting an increase in appropriations and estimated revenues for increased salary and benefit costs in the amount of \$50,000. County Employees Management Association (CEMA) negotiated a new labor agreement beginning in Fiscal Year 2024-25 and the cost increase resulting from this agreement was not incorporated into the Fiscal Year 2024-25 Adopted Budget, in addition to increased funding received in Calendar Year 2025 that recently became available to support County staff salaries for ongoing activities relevant to the Community Action Partnership appropriations unit; and

**WHEREAS**, there would be no cost to the County with this item. The increased appropriations are financed by the federal Community Services Block Grant revenues as part of the County's calendar year 2025 award; and

**WHEREAS**, the Monterey County Social Services requires increased appropriations and estimated revenues of \$50,000 in the Community Action Partnership Fund 008, Appropriations Unit SOC007, Fiscal Year 2024-25 Adopted Budget.

**NOW, THEREFORE, BE IT RESOLVED**, the Board of Supervisors of the County of Monterey hereby:

Authorize and direct the Auditor-Controller to amend the Fiscal Year 2024-25 Adopted Budget by increasing appropriations and estimated revenues by \$50,000 in Social Services – Community Action Partnership Budget, Fund 008, Dept. 5010, Appropriation Unit SOC007 to provide funding to support staff salaries for ongoing activities relevant to the Community Action Partnership appropriations unit (4/5<sup>ths</sup> vote required).
