Amendment No. 1 To Standard Agreement By and between Awender Chiropractic Health Services, Inc. ("Contractor"), and

This Amendment No. 1 ("Amendment No. 1") is made and entered into, by and between the County of Monterey, a political subdivision of the State of California, hereinafter referred to as "COUNTY", and Awender Chiropractic Health Services, Inc., a California general stock corporation, hereinafter referred to as "CONTRACTOR".

County of Monterey, on behalf of its Health Department ("County")

RECITALS:

WHEREAS, the COUNTY and CONTRACTOR have heretofore entered into an Agreement to provide on-site licensed chiropractors for health services to patients for the period of April 15, 2024, to April 30, 2026, and for an amount not to exceed \$198,000.00 ("Agreement"); and

WHEREAS, the COUNTY and CONTRACTOR wish to increase the amount of the Agreement by \$718,240, for a new contract amount not to exceed \$916,240.

NOW THEREFORE, the COUNTY and CONTRACTOR hereby agree to amend the Agreement, as follows:

1. <u>Section 2.0</u>. Section 2, PAYMENT CONDITIONS, is hereby amended and restated to read in its entirety as follows:

"2.0 PAYMENT PROVISIONS:

County shall pay the CONTRACTOR in accordance with the payment provisions set forth in Exhibit A, subject to the limitations set forth in this Agreement. The total amount payable by County to CONTRACTOR under this Agreement shall not exceed the sum of \$916.240."

- 2. EXHIBIT A Scope of Services/Payment Provisions is amended and replaced in its entirety with Amendment No. 1 to EXHIBIT A. All references in the Agreement to EXHIBIT A shall be construed to refer to Amendment No. 1 to EXHIBIT A
- 3. Except as provided herein, all remaining terms and conditions and provisions of the Agreement are unchanged and unaffected by this Amendment No. 1 and shall continue in full force and effect as set forth in the Agreement.
- 4. A copy of this Amendment No. 1 shall be attached to the Agreement.
- 5. This Amendment No. 1 shall be effective upon execution by both parties.
