AMENDMENT NO. 1 TO STANDARD AGREEMENT BETWEEN COUNTY OF MONTEREY AND WESTERN OILFIELDS SUPPLY COMPANY DBA RAIN FOR RENT

THIS AMENDMENT NO. 1 to the Standard Agreement between the County of Monterey, a political subdivision of the State of California (hereinafter, "County") and Western Oilfields Supply Company dba Rain for Rent (hereinafter, "CONTRACTOR") is hereby entered into between the County and the CONTRACTOR (collectively, the "Parties") and effective as of the last date opposite the respective signatures below.

WHEREAS, CONTRACTOR entered into a Standard Agreement with County on April 28, 2016 (hereinafter, "Agreement") to provide labor and/or equipment rental for common storm water pumping system elements required for storm water pumping projects as needed by the County of Monterey, Resource Management Agency (hereinafter, "services") through September 30, 2017 for an amount not to exceed \$10,000; and

WHEREAS, the County has a continued need for services; and

WHEREAS, the CONTRACTOR's original rate sheet requires an update effective October 1, 2017; and

WHEREAS, additional time and funding are necessary; and

WHEREAS, the Parties wish to amend the Agreement to extend the term for three (3) additional years to September 30, 2020, to increase the amount by \$30,000 for a total not to exceed amount of \$40,000, and to update the Rate Sheet effective October 1, 2017 to allow CONTRACTOR to continue to provide services identified in the Agreement and as amended by this Amendment No. 1.

NOW, THEREFORE, the Parties agree to amend the Agreement as follows:

1. Amend Paragraph 2.01 under Section 2.0, "Payment Provisions", to read as follows:

County shall pay the CONTRACTOR in accordance with the payment provisions set forth in Exhibits A and A-1, subject to the limitations set forth in this Agreement. The total amount payable by County to CONTRACTOR under this Agreement is not to exceed the sum of \$40,000.

2. Amend the first sentence of Paragraph 3.01 under Section 3.0, "Term of Agreement", to read as follows:

Amendment No. 1 to Standard Agreement Western Oilfields Supply Company dba Rain for Rent Storm Water Labor/Equipment Rental RMA – Public Works and Facilities Term: May 1, 2016 – September 30, 2020 Not to Exceed \$40,000

- The term of this Agreement is from May 1, 2016 to September 30, 2020, unless sooner terminated pursuant to the terms of this Agreement.
- 3. Amend Paragraph 4.01 under Section 4.0, "Scope of Services and Additional Provisions", to add "Exhibit A-1 Revised Rate Sheet, effective October 1, 2017".
- 4. In all places within the Agreement, any reference to County's address at 168 West Alisal Street, 2nd Floor, Salinas, California, 93901, is hereby replaced with 1441 Schilling Place, South 2nd Floor, Salinas, California, 93901-4527.
- 5. In all places within the Agreement, any reference to the CONTRACTOR's original Rate Sheet is hereby replaced with the CONTRACTOR's revised Rate Sheet, effective October 1, 2017, in "Exhibit A-1 Revised Rate Sheet, Effective October 1, 2017".
- 6. Amend Paragraph A.1 under Section A. "Scope of Services" of Exhibit A Scope of Services/Additional Provisions/Payment Provisions, to delete "Public Works".
- 7. Amend Paragraph B.1 under Section B. "Payment Provisions" of Exhibit A Scope of Services/Additional Provisions/Payment Provisions to include the following:
 - "Any changes to the rates must be approved in writing by the County and CONTRACTOR prior to the effective date of any rate increase."
- 8. All other terms and conditions of the Agreement remain unchanged and in full force.
- 9. This Amendment No. 1 shall be attached to the Agreement and incorporated therein as if fully set forth in the Agreement.
- 10. The recitals to this Amendment No. 1 are incorporated into the Agreement and this Amendment No. 1.
