**WHEREAS**, **Ian Oglesby** has served as a Monterey County Board of Education Trustee and served 6 years as a Seaside Planning Commissioner, and currently serves on the Board of Monterey College of Law; and

**WHEREAS**, **Ian Oglesby** currently serves as Treasurer for LULAC Monterey Peninsula Council and the NAACP Silver Life Member and also serves with the African American Caucus and previously served on the Board of the United Way of Monterey County and was Past Chair of Leadership Monterey Peninsula (now Leadership Monterey County).
