AMENDMENT # 1 to MONTEREY COUNTY AGREEMENT # A-12769
(UC Davis Agreement #A20650)

Regents of the University of California, UC Davis Extension

This Amendment is made and entered into by and between the County of Monterey, a political subdivision of the State of California, (hereinafter, "COUNTY"), and The Regents of the University of California, UC Davis Extension (hereinafter, "CONTRACTOR").

This Amendment modifies the agreement for the provision of staff training between the parties executed on July 13, 2015, by adding \$78,210 for 22 additional training units, effective November 1, 2015, increasing the total contract amount to \$149,310. Therefore, the parties agree:

- 1. Exhibit A of the Original Agreement is amended to read as follows:

TRAINING PROGRAM

- 1. 42.0 Unit(s) of training in the subject areas selected by the agency from the UC Davis Extension curriculum.
2. University will provide the following:
a. Needs assessment, curriculum planning and implementation.
b. Instructional and student services.
c. Instructional materials
d. Evaluation and feedback.
e. Continuing education credit.
f. Food and non-alcoholic beverages when requested by the User in writing. (Extra training units may be charged.)
g. Any other items when requested by the User in writing and approved by University. (Extra training units may be charged.)
3. User will provide the following:
a. Training facility and audio-visual equipment.
b. On-site coordination of training.

Special classes, workshops, and leadership classes offered by UC Davis, and customization of classes listed in the UC Davis catalog, may consume additional units of training at increments of .25 or .10 of one unit of training.

If there is any conflict or inconsistency between the provisions of the AGREEMENT or this AMENDMENT, the provisions of this AMENDMENT shall govern. A copy of this AMENDMENT shall be attached to the original AGREEMENT, as it may have been previously amended.

Except as provided herein, all remaining terms, conditions, provisions, entitlements and obligations of the original AGREEMENT shall remain unchanged and unaffected by this AMENDMENT and shall continue in full force and effect.
