2	Per RFP page 9, Section 5.2.2 Spare Equipment – what type of software should be maintained for the referenced Type 170 and Type 2070 controllers?	Both Type 170 E and Type 2070E Controllers take the 2033 Program Software
3	Per RFP page 9, Section 5.2.3 Aging Equipment and Replacement – “Contractor shall replace five (5) traffic signal controllers per year...” Can you provide details regarding the proposed new 2070 controller? i. Software? ii. 2070 controller modules to be included? iii. 2070-3A display module? iv. Will this controller be charged as extra item per Attachment C: Pricing Schedule Item No. 2 or will this replacement considered included in the cost of annual maintenance? In other words, are the costs associated with the five (5) controller replacement to be included in “Traffic Signal Monthly/Annual Maintenance”	County plans to replace/upgrade aging components. New 2070 controllers shall be NEMA Type 2070E McCain i. Software is 2033 McCain Program Software (or as approved by County) ii. A new controller would be assigned to and charged to the intersection, with the work order provided by the County. iii. Quantity and locations of 2070-3A display module to be determined by County with the selected CONTRACTOR. iv. This replacement is considered to be an additional cost separate from annual maintenance.
4	Per RFP Page 9, Section 5.2.4 LED Replacement, Servicing and Testing – The RFP states that “Contractor shall replace all incandescent lamps in all signal heads based on an eighty percent depletion period. All incandescent shall be replaced with LED modules.” Can the County clarify the number of incandescent lamps currently in the field? Additionally, are these replacements considered an extra charge, or are they to be included in the preventative maintenance unit price? Understanding the quantity of non-LED units is critical for accurate budgeting if replacement costs are to be included.	The County currently does not have an accurate count of incandescent lamps currently in the field. Replacement will be with LED Heads if a failure in the field takes place. Parts would be an extra charge applied to the location that has an approved work order provided by the County.

5	Per RFP Page 9, Section 5.2.6 ...”test all suspect 8” and 12” red LED modules...” - Per the RFP requirement for annual LED intensity testing and lens cleaning: Can the County clarify whether it will provide historical test results or a baseline inventory of red LED modules previously tested or replaced? Additionally, are there any existing thresholds or guidelines for what constitutes “light intensity degradation” that would warrant replacement? This information would help us better estimate the scope of anticipated repairs.	The County can provide historical logs of each intersection to the selected CONTRACTOR. Guidelines for Light intensity degradation are as outlined in CALTRANS specifications.
6	Per RFP page 11 Section 5.2.7 Regarding the annual testing of Battery Backup Systems (BBS) and PROM module lithium batteries: a. Will the County provide a standardized report format or template in advance for submission, or should the Contractor propose a format for approval? b. Additionally, can the County confirm the expected quantity and location of PROM modules requiring lithium battery replacement, to ensure accurate inclusion in monthly preventive maintenance billing?	a. The County does not have a standard report format or template to provide in advance of submission for annual testing of the BBS and PROM module lithium batteries. County and selected CONTRACTOR shall coordinate to develop a standard report format that is mutually beneficial. b. Currently the County has been programming replacement of all BBS for the 29 signals with TESCO BBS and batteries. The County cannot confirm the expected quantity and location of PROM modules requiring lithium battery replacement at this time. County shall coordinate with selected CONTRACTOR based on needs and priorities.
7	Per RFP page 42-48 – Attachment C – Pricing Schedule – The proposed unit rate is “Per Month / Per Year” – if the proposed per month per signal cost is “\$100 per month per signal” – is the correct way to complete the pricing schedule “\$100 / \$1200”?	Yes. As another example, if the proposed per month per signal cost is \$70 per month, then the per year cost would be multiplied by 12, and the cost would be written as \$70/840.
8	Could the County provide a copy of the current contractor’s pricing schedule for reference?	Please refer to the response provided for Question 1.
9	Would the County be able to share sample invoices from the current contract to better understand the existing billing structure and format?	Please see Sample Invoices
10	Per RFP Page 49, Bid Item No. 4 – “Straight Time, Inductive Loop Installer	

	(1 loop)": Can the County clarify whether this item refers to the hourly labor rate for an inductive loop installer during straight time, or the total cost to install one loop under straight time conditions?	This item refers to the straight-time hourly labor rate for an inductive loop installation. Example: Maint/Hourly Rate \$500/per loop
11	Per RFP Page 49, Bid Items 1–4 under "Testing When Requested": Can the County clarify whether these items refer to testing newly installed components or testing of existing in-field and operational equipment? Understanding the context will help ensure accurate pricing and scope alignment.	"Testing When Requested" on page 49 of RFP #10915 is applicable when the County needs specific testing to any Item listed in in Bid Items 1 – 4 when needed whether it is newly installed, or existing in-field and operational equipment.
12	Per RFP Page 48 – 49 for items under "Maintenance /Hourly Rate" and "On-Call Repair / Hourly Rate" – is the difference between the two categories Straight Time and Overtime/Doubletime Charges? Furthermore, under "On-Call Repair / Hourly Rate" - are service truck or bucket truck charges to be included in Items 1-4? Or will equipment charges be billed in additional to these rates.	The difference between Maintenance/Hourly Rate and On-Call Repair/Hourly Rate is dependent on each contractor's business plan. Straight time would be charged during standard working hours. If an on-call situation arises in an overtime capacity, charges should be within the quoted bid item. Equipment Charge can be the same in Straight Time as in Over Time but if Contractor proposes a difference in pricing, it should reflected in this proposal.
13	Per RFP Page 49, "Maintenance / Hourly Rate" – Bid Item No. 9 "Material Cost": Can the County clarify the unit basis for "Material Cost"? Is this intended as a markup percentage, a placeholder for actual costs, or a fixed unit price for commonly used materials?	Bid Item No. 9 Material Cost unit basis for Material Cost is a place holder for actual costs.
14	Per Page 9, Section 5.2.6 – LED Intensity Testing: The RFP specifies the use of the KLIGHT TLM-100 meter. We are currently in contact with K-Light Laboratories to obtain pricing. In the event that the TLM-100 is no longer available, can the County provide a list of acceptable alternative meters for use? Additionally, can the County confirm that all testing must occur in April, as stated in the RFP?	The County will consider alternatives to the KLIGHT TLM-100 Meter that are comparable in quality. Yes, testing must occur in April of each year unless a different month has been authorized in writing by the County Traffic Engineering Team.

15	Since the specified TLM-100 meter specified in the RFP has been officially discontinued and is no longer available on the market - can the County please confirm whether an alternative meter may be used? If so, could the County provide a list of approved or recommended equivalent devices for LED intensity testing? If not, we recommend removing LED intensity testing altogether.	Any equivalent brand of meter of the same type and quality can be used, subject to County approval.
