LEGAL DESCRIPTION

Being a portion of Block 35 as shown on a map in Volume 1 Cities and Towns at Page 55 recorded in the Recorders office of Monterey County, State of California, in the unincorporated territory of said county known as Castroville and more practically described as follows:

Beginning at a Permanent Monument located on the center line of Geil Street (originally a 50 foot road) near the intersection with Pajaro Street as shown on the Property Monumentation Map on file in the in the County Surveyors Office in Volume A of Property Monumentation Maps at Page 111, records of said County, thence North $42^{\circ} 31' 12''$ East 30 feet to the most Southerly comer of said Block 35, as shown on said Property Monumentation Map; Thence North $47^{\circ} 22' 30''$ West 15.03 feet to the TRUE POINT OF BEGINNING; Thence continuing North $47^{\circ} 22' 30''$ West and along the Northerly line of said Geil Street 105.00 feet; Thence leaving said northerly line North $42^{\circ} 31' 12''$ East 62.38 feet; Thence North $89^{\circ} 01' 19''$ East 83.59 feet; Thence South $47^{\circ} 22' 30''$ East 59.39 feet to the Northwesterly line of Pajaro Street, a 60' county road, thence South $42^{\circ} 31' 12''$ West 105.00 feet along said county road to the Beginning of a tangent curve, concave to the North with a central angle of $90^{\circ} 06' 18''$, a radius of 15 feet, and an arc length of 23.59 feet; Thence along the arc of said curve in a Westerly direction 23.59 feet to the TRUE POINT OF BEGINNING.
