WHEREAS, Mario A. Salazar began his career with the County of Monterey on July 15, 2000, with the County's General Services Department as the **Contracts and Purchasing Manager** responsible for the County's centralized purchasing, contracting and related functions; and

WHEREAS, Mario A. Salazar in 2005 under the creation of the County's Resource Management Agency, transitioned into the Public Works-Facilities Division's **General Services Manager III** position responsible for safe and efficient operation of occupied and non-occupied County facilities and grounds; and

WHEREAS, Mario A. Salazar in 2020 under the creation of the Public Works, Facilities and Parks Division reclassified into the **Facilities Maintenance Manager** position, until his retirement from the County on November 14, 2024; and

WHEREAS, during his long years of service, **Mario A. Salazar,** in collaboration with County Counsel and the Auditor Controller departments, issued a new County of Monterey Purchasing Manual in 2001, which currently remains in effect; and

WHEREAS, Mario A. Salazar managed creation and implementation of the first County of Monterey Records Retention Center in 2002, and

WHEREAS, Mario A. Salazar managed implementation of the first comprehensive County of Monterey Contracts Database, which expedited information retrieval; and

WHEREAS, Mario A. Salazar served as Logistics Chief for the County of Monterey Emergency Services Department for a term of five years, and continued service during winter storm and wildfire events throughout his tenure with the County of Monterey

WHEREAS, Mario A. Salazar served as an Monterey County ADA Commissioner for a term of six years: and

WHEREAS, Mario A. Salazar, in his capacities of Contracts-Purchasing Manager and Public Works Facilities Maintenance Manager, served all 26 County of Monterey departments in a diligent, professional manner in compliance with local, state and federal codes and regulations;

NOW, THEREFORE, BE IT RESOLVED that the Monterey County Board of Supervisors, on behalf of the County and all the residents thereof, hereby acknowledges, commends, and thanks ***Mario A.
