AMENDMENT NO. 1 TO STANDARD AGREEMENT BETWEEN COUNTY OF MONTEREY AND ALEX J. VATSULA dba VATSULA VISUALS

THIS AMENDMENT NO. 1 to the Standard Agreement between the County of Monterey, a political subdivision of the State of California ("County") and Alex J. Vatsula dba Vatsula Visuals ("CONTRACTOR") is hereby entered into between the County and the CONTRACTOR (collectively, the "Parties") and retroactively effective as of June 18, 2024.

WHEREAS, CONTRACTOR entered into a Standard Agreement with the County on June 21, 2024 ("Agreement") to provide comprehensive audio/visual support and live-streaming services for the Virtual Meeting Technical Support organized by the County through June 30, 2027 for an amount not to exceed \$15,000;

WHEREAS, due to the lack of timely responses and approval delay, the Agreement was not executed until June 21, 2024; and

WHEREAS, the Parties wish to further amend the Agreement's effective date to June 18, 2024, with no change in the Agreement amount of \$15,000.

NOW, THEREFORE, the Parties agree to amend the Agreement as follows:

- 1. Amend the first sentence of Section 3, "Term of Agreement," to read as follows:
 - The term of this Agreement is from <u>June 18, 2024</u> to <u>June 30, 2027</u>, unless sooner terminated pursuant to the terms of this Agreement.
- 2. Except as amended herein, all other terms and conditions of the Agreement, including all Exhibits thereto, remain unchanged and in full force and effect.
- 3. This Amendment No. 1 shall be attached to the Agreement and incorporated therein as if fully set forth in the Agreement.
