CSA-74
Special Tax

Primary source of funding

Has not increased since FY1999-00

Generates approximately \$1.9M in revenue each year



Administration of Maddy Fund

Based on collection of fee added to certain court fines

Restricted use source of funding

Currently, the fee is \$178,204.

Distribution methodology set in Health & Safety Code

Provides approximately \$190K in funding

Maddy revenues have been decreasing since FY22-23



- Basic unit is a single-family dwelling.

EFFORTS TO INCREASE REVENUE

Increase in Special Tax

- Requires a vote by residents of Monterey County
- Requires EMS to cover its share of the cost of running the election

Increase in General Fund Contribution

- Competition from all County Departments
- Requires approval of the Board of Supervisors

Grants

Resource intensive

Implementation of New Fees

- Charged by LEMSAs across the state
- Purpose to recover at least part cost of operating programs
- Monterey is one of the few LEMSAs not charging fees
