WHEREAS, Natividad administration staff requested a base wage compensation study of the Hospital Environmental Services Aide, Hospital Senior Environmental Services Aide and Hospital Supervising Environmental Services Aide classifications; and

WHEREAS, Natividad conducted a base wage compensation study of the Hospital Environmental Services Aide classification which determined Hospital Environmental Services Aide is approximately 10.60% below the mean of the County's comparable agencies and it is recommended to adjust the base wage salary of Hospital Environmental Services Aide by the approximate percentage identified at top step; and

WHEREAS, Natividad further recommends adjusting the base wage salary of Hospital Senior Environmental Services Aide and Hospital Supervising Environmental Services Aide by approximately 10.60% at top step in order to maintain the spread of the series; and

WHEREAS, to implement the recommendations, the actions require the Personnel Policies and Practices Resolution No. 98- 394 Appendix A to be amended;
