In consideration of the Air District's Offer of up to \$25,000 to purchase one (1) Nissan Leaf, Model S with QC from an authorized Nissan Leaf dealer, the undersigned accepts the Air District's Offer on behalf of the County of Monterey, Agricultural Commissioner's Office, and agrees to the following terms and conditions:

## COUNTY AGRICULTURAL COMMISSIONER'S OFFICE TERMS AND CONDITIONS

- 1. The County agrees to the removal from the fleet of one gas or diesel powered vehicle (to be) replaced by the EV and to adequately brand the Nissan Leaf as a zero emission vehicle funded by the Air District.
- 2. Upon acceptance, the County will need to take delivery of a Nissan Leaf Electric Vehicle, Model S with QC from an authorized Nissan Leaf dealer no later than **June 30, 2014**.
