#### IMPACTS TO HEALTH AND SOCIAL SERVICES

Increased demand for social services, emergency housing vouchers, unemployment benefits, etc.

Impacts to health risks due to mold and contaminated soils.

#### **IMPACTS TO HOUSING**

Nearly every home in Pajaro was impacted, even those without high water marks.

250 residential structures damaged or destroyed by flooding Close to \$100 million in damages.

#### IMPACTS TO NATURAL AND CULTURAL RESOURCES

Damage to the Pajaro Middle School, Ag. Commissioner's Office, Library, and the historic water tower.

Flooding causes erosion of the land taking nutrients from the soil.

#### IMPACTS TO INFRASTRUCTURE

Damage to roads, public water systems, sewage main, and the levee. Disruption of services like clean drinking water, and sewage. Close to \$60 million in damages

#### IMPACTS TO ECONOMY


Approximately \$600+million in damages to the agricultural industry.


Approximately \$30 million in damages to businesses and commercial structures.

#### **IMPACTS TO PUBLIC SAFETY**

More than 3,000 residents evacuated in the Community of Pajaro. Increased demand on public safety resources.

Close to 250 high water rescues.






## **Pajaro Revitalization Committee**

- The Pajaro Revitalization Committee was established in mid-July to develop an inclusive recovery community led plan for the township of Pajaro.
- The overarching objective the Task Force is:
  - To ensure a resilient and sustainable recovery.
  - To strengthen the community's preparedness for future disasters.
  - To include residents in the recovery planning work and processes.



## Long-Term Recovery Plan

Long Term Recovery Planning is the process of establishing a community-based, post-disaster vision and identifying projects and project funding strategies best suited to achieve that vision, and employing a mechanism to implement those projects



## **Assembly Bill 102**


The County of Monterey has been allocated \$20 Million from the State budget for Pajaro recovery efforts.

### Requirements

- Disbursed in the community of Pajaro
- No duplication or replacement of benefits available or received through other existing assistance programs
- Must be expended by December 31, 2025
- Subject to State Audit
- Nexus with flood relief, response, recovery, mitigation, preparedness, and resilience

- No other funding available
- Immediate recovery need
- Community support and impact
- Feasibility
- One-time project

### **UNMET NEEDS**

Undocumented Flood Survivors (Non-FEMA Eligible Survivors)

- Economic assistance for unmet needs provided to eligible individuals who experienced hardship from the storms and cannot access federal assistance due to immigration status.
- Direct assistance payments will be provided for the purpose of helping storm impacted individuals and households cover certain necessary costs including housing, food, transportation costs, and financial relief for lost wages.

### SMALL BUSINESS FLOOD RECOVERY

Workforce Development Board

- Small businesses who suffered flood related losses not covered by other assistance programs or insurance.
- Survey and Damage Assessments: estimated 50 small business with a need of \$25,000 – \$60,000
- Funds would require recipients to provide a business plan to show how funds would be used.
- Grant awards would be distributed in multiple funding phases.

**Level 3** Major Repairs and Personal Property Damage

**Level 2** Medium Repairs and Personal Property Damage

**Level 1** Minor Repairs and/or Personal Property Damage A disaster caused **"Unmet Need"** is the deficit between verified disaster-caused damages and obtainable disaster aid, including insurance assistance, Federal and State assistance, and personal resources. Includes:

- Personal Property Losses and Household Items
- Temporary Shelter and Housing Needs
- Emotional, Spiritual, and Mental Health Care
- Home Repair and Rebuilding

Includes both Renters and Property Owners.

Clear Criteria, Guidelines, and Priority will be developed in partnership with the State Contracted Disaster Case Management Agencies.



- g. Authorize and Direct the Auditor-Controller and County Administrative Office to incorporate these changes in FY 2023-24 Department of Emergency Management Adopted Budget (001-1040-8588-DEM001), 4/5th vote required.
