**WHEREAS**, The Santa Cruz-Monterey-Merced Managed Medical Care Commission is the governing board for Central California Alliance for Health and is composed of County Board of Supervisors Representative, County Health Department Representatives, Hospital Representatives, Providers Representatives and Public Representatives; and

**WHEREAS**, **Julie Edgcomb** has over 40 years of work experience in human services, including criminal justice, secondary and post-secondary education, vocational rehabilitation and health; and

**WHEREAS**, Before retiring in late 2019, **Julie Edgcomb** was the Ambulatory Services Administrator for Natividad Medical Center and the Monterey County Health Department, with responsibility for twelve primary care and multi-specialty clinics; and

**WHEREAS**, **Julie Edgcomb** earned a Bachelor of Arts in Psychology at the University of California, Santa Cruz and a Master's Degree in Education at Chapman University; and

**WHEREAS**, **Julie Edgcomb** served on the Central Coast Alliance for Health Board of Commissioners from May 28, 2003, to September 27, 2023, as a Public Representative.
