Adopt a Resolution to:

Exercise the Board of Supervisors option under California Government Code 53853 (b) to notify the King City Union Elementary, Monterey Peninsula Unified, and the Pacific Grove Unified School Districts pursuant to the attached Resolution that it will not authorize the issuance of tax and revenue anticipation notes ("TRANS") of the Districts and to provide such notification on or before June 30, 2019.

**WHEREAS**, Pursuant to Government Code Section 53853, the King City Union Elementary School District, Monterey Peninsula Unified School District, and the Pacific Grove Unified School District have issued resolutions requesting that the County of Monterey issue tax and revenue anticipation notes (TRAN's) for the Districts, requesting action by the County on or before June 30, 2019.

**WHEREAS**, due to economies of scales and costs, it is not in the County of Monterey's nor the School District's best interests to have the County issue the requested TRANS and that Government Code Section 53853 (b) permits the County to decline the request, which will permit the aforementioned School Districts to proceed to have the TRANS issued on their own; and,

**WHEREAS**, this Resolution will provide sufficient time and opportunity for the School Districts to proceed with the TRANS on their own;

**NOW, THEREFORE, BE IT RESOLVED** that the Monterey County Board of Supervisors exercise the option under California Government Code 53853 (b) to notify the King City Union Elementary, Monterey Peninsula Unified, and the Pacific Grove Unified School Districts pursuant to the attached Resolution that it will not authorize the issuance of tax and revenue anticipation notes ("TRANS") of the Districts and to provide such notification on or before June 30, 2019.


