**WHEREAS**, On December 27, 2020, the Consolidated Appropriations Act, 2021 (Pub.L. No. 116-260) (the “Act”) was signed into law. Section 501 of Division N of the Act established the federal Emergency Rental Assistance Program (“**ERAP**”) and authorized the direct allocation of emergency rental assistance funds to states, units of local government, tribal communities, and territories. The ERAP funds are intended to assist households that are unable to pay rent and utilities due to the COVID-19 pandemic; and,

**WHEREAS**, California Senate Bill No. 91 (2021-2022 Reg. Sess.) (“**SB 91**”) established the State of California’s program for administering its share of ERAP funds (the “**State Rental Assistance Program**,” “**SRAP**,” or “**State Rental Assistance Funds**”). SB 91 added Chapter 17 (commencing with Section 50897) to Part 2 of Division 31 of the Health and Safety Code. Health and Safety Code section 50897.1, subdivision (a)(1) authorizes the Department of Housing and Community Development to administer the State Rental Assistance Funds in accordance with state and federal law; and,

**WHEREAS**, On January 26, 2021, The County of Monterey received a direct allocation of ERAP funds from the U.S. Department of the Treasury and the Department of Social Services requests Monterey County Board of Supervisors accepts the amount of \$12,905,388; and,

**WHEREAS**, the Department of Social Services requests Monterey County Board of Supervisors accepts the State of California Block Grant funding in the amount of \$15,391,449; and,

**WHEREAS**, Social Services requires an increase in appropriations and estimated revenues of \$17,000,000 for the Emergency Rental Assistance Program in the Social Services Community Programs Budget Unit 001-5010-SOC004-8258 FY 2020-21 Adopted Budget (4/5ths vote); and

**WHEREAS**, the Board of Supervisors will need to authorize and direct the Auditor-Controller to amend the FY 2020-21 Adopted Budget by increasing appropriations and revenues by \$17,000,000 in the Social Services Community Programs Budget Unit 001-5010-SOC004-8258 (4/5ths vote required).

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Supervisors for the County of Monterey as follows:

- a. Accepted Block Grant funds from State of California, Department of Housing and Community Development in the amount of \$15,391,449 for the State Emergency Rental Assistance Program;
- b. Accepted the federal award from the U.S. Department of the Treasury in the amount of \$12,905,388 for Emergency Rental Assistance;
- c. Approved an increase in appropriations and estimated revenues of \$17,000,000 for Social Services 001-5010-SOC004-8258 in the FY 2020-21 Adopted Budget (4/5<sup>th</sup> vote required); and
- d. Authorized and direct the Auditor-Controller to amend the FY 2020-21 Adopted Budget Social Services 001-5010-SOC004-8258 increasing appropriations and revenues by \$17,000,000 from a State of California, Department of Housing and Community Development block grant (\$15,391,449) and a federal award from the U.S. Department of the Treasury (\$12,905,387) for the Emergency Rental Assistance Program.(4/5<sup>th</sup> vote required).
