WHEREAS, Natividad conducted a base wage compensation study of the Dietitian classification which determined Dietitian is approximately 11.47% below the mean of the County's comparable agencies and it is recommended to adjust the base wage salary of Dietitian by the approximate percentage identified at top step; and

WHEREAS, Natividad further recommends adjusting the base wage salary of Supervising Dietitian by approximately 11.47% at top step in order to maintain the spread of the series; and

WHEREAS, to implement the recommendations, the actions require the Personnel Policies and Practices Resolution No. 98- 394 Appendix A to be amended;
