WHEREAS, the American Legion Honor Guard provides Military Funeral Honors designed to Honor the lives of all Veterans who have served their Country in the Armed Forces, their families, and their survivors for the past 45 years; and

WHEREAS, the Honor Guard voluntarily covers the Tri-County area with Military Honors, sometimes conducting up to three a day, and up to six days straight and holds a firm "Never leave a Fallen Comrade" attitude; and

WHEREAS, during 2015 the Honor Guard registered 2100 volunteer hours conducting services, Legion assistance, and fundraisers; and

WHEREAS, the Honor Guard financially relies solely on internal fundraisers and donations to absorb the costs of maintenance of equipment, transportation, uniforms, and purchase of Burial Flags for services; and

WHEREAS, during 2015 there are fourteen active members of the Honor Guard, three retired members, and two of whom are deceased; all Honor Guard members are Veterans and/or Family Members of Veterans who have all served Honorably in the United States Armed Forces;

NOW, THEREFORE BE IT RESOLVED, that the Monterey County Board of Supervisors, on behalf of the County and all Citizens thereof, honors the service of the American Legion, District 28, Honor Guard, on their long and dedicated efforts to bring these services to culmination and in recognition of their Honorable Service to our County, State and Nation; the County of Monterey proclaims acknowledgement to the Honor Guard.
