

TO AGREEMENT BY AND BETWEEN COUNTY OF MONTEREY AND CASE IQ

THIS AMENDMENT NO. 4 to Agreement No. A-13724 between the County of Monterey, a political subdivision of the State of California (hereinafter, "County") and **Case IQ (i-Sight)** (hereinafter, "CONTRACTOR") is hereby entered into between the County and the CONTRACTOR (collectively, the "Parties") and effective as of the last date opposite the respective signatures below.

WHEREAS, CONTRACTOR entered into Agreement No. A-13724 with County on September 18, 2017 (hereinafter, "Agreement") to provide Case Management Software services (hereinafter, "services") for the period of August 31, 2017 to August 31, 2020 for an amount not to exceed \$22,500; and

WHEREAS, CONTRACTOR entered into Amendment No. 1 to Agreement No. A-13724 with County on July 2, 2019 to extend the term of the Agreement to August 31, 2023, and increase the amount of the contract by \$25,000; and

WHEREAS, CONTRACTOR entered into Amendment No. 2 to Agreement No. A-13724 with County on May 25, 2021 to extend the term for five (5) additional years from May 31, 2021 to May 30, 2026, and increase the amount of the contract by \$57,400 for a total amount not to exceed \$104,900; and

WHEREAS, CONTRACTOR entered into Amendment No. 3 to Agreement No. A-13724 with County on June 24, 2022 to extend the term ending date for seven (7) months from May 30, 2026, to December 31, 2026, at no additional cost; and

WHEREAS, County has a continued need for services; and

WHEREAS, additional time is necessary to allow CONTRACTOR to continue to provide the services required by the County; and

WHEREAS, the Parties wish to amend the Agreement to extend the term for three (3) additional years from December 31, 2026 to December 31, 2029, and increase the amount by \$32,604 for a total not to exceed amount \$137,504 to allow CONTRACTOR to continue to provide services identified in the Agreement as amended by this Amendment No. 4.

NOW THEREFORE, the Parties agree to amend the Agreement as follows:

1. Amend Paragraph 2, "Payments by County", to read as follows:
2. County shall pay the CONTRACTOR in accordance with the payment provisions set forth in Exhibit A, subject to the limitations set forth in this Agreement. The total amount payable by County to CONTRACTOR under this Agreement shall not exceed the sum of \$137,504.
3. Amend the first sentence of Paragraph 3, "Term of Agreement", to read as follows:

The term of this Agreement is from December 31, 2026, to December 31, 2029, unless sooner terminated pursuant to the terms of this Agreement.

4. All other terms and conditions of the Agreement, including all Exhibits thereto, remain unchanged and in full force.


