WHEREAS, during contract negotiations with the Union of American Physicians and Dentist (UAPD), parties agreed that medical service line directors would not be covered under the negotiated Memorandum of Understanding (MOU) provisions; and

WHEREAS, the County identified a need to establish an unrepresented unit for medical service line directors; and

WHEREAS, Natividad Medical Center completed a classification and compensation study of the medical service line directors and the study determined a need to create two (2) classifications of Services Director/Medical Director – Contract Physician and Services Director/Medical Director – Contract Physician Specialty Services with broad salary ranges; and

WHEREAS, to implement the recommendation, the action requires the Personnel Policies and Practices Resolution No. 98-394 to be amended;

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors in and for the County of Monterey as follows:
