THIS AGREEMENT, made in triplicate by and between the COUNTY OF MONTEREY, a political subdivision of the State of California, hereinafter called the "County," and Telfer Pavement Technologies, LLC, hereinafter called the "Contractor," WITNESSETH:

(1) THE WORK
