WHEREAS, **Jeff and Carolyn Craig** have been active members of the Carmel Presbyterian Church for the entirety of their Monterey Peninsula residency; and

WHEREAS, **Jeff and Carolyn Craig** were hard workers, with Jeff starting at Monterey Insurance Agencies in 1971, staying until he retired in 2011, and Carolyn working as a preschool teacher in Pacific Grove, Monterey, and Seaside for over a decade; and
