Adopt a resolution honoring **Arturo Perez** as a Monterey County Military and Veterans Affairs Advisory Commission's Veteran of the Year for 2024.

WHEREAS, **Arturo Perez** was recently voted as the City of Gonzales Volunteer of the Year, demonstrating his commitment to his local community, and continues his honorable service as a Navy Retiree by doing all that he can for veterans in our community; and

WHEREAS, we extend our deepest appreciation and honor to **Arturo Perez** for his unwavering commitment and tireless efforts in pursuit of caring for the health, welfare, and well-being of residents, our esteemed veterans, and their families.
