WHEREAS, Natividad Medical Center (NMC) administration staff requested a base wage compensation study of the Interventional Radiologic Technologist classification series; and

WHEREAS, NMC conducted a base wage compensation study of the Interventional Radiologic Technologist classification which determined Interventional Radiologic Technologist is approximately 8.74% below the mean of the County's comparable agencies and it is recommended to adjust the base wage salary of Interventional Radiologic Technologist by the approximate percentage identified at top step; and

**WHEREAS,** NMC further recommends adjusting the base wage salary of Senior Interventional Radiologic Technologist and Interventional Radiologic Technologist-Per Diem by approximately 8.74% at top step in order to maintain the spread of the series; and

**WHEREAS,** to implement the recommendations, the actions require the Personnel Policies and Practices Resolution No. 98- 394 Appendix A to be amended;
