WHEREAS, the Monterey County Health Department will use these funds for activities related to the State Water Board's Waste Discharge Permit Fund and the Beaches Environmental Assessment and Coastal Health Act Grant Program, which fall within their Water Beach Safety Program; and

WHEREAS, the Monterey County Health Department is authorized to enter into a financial assistance agreement with the State of California and the State Water Board;

**NOW, THEREFORE, BE IT RESOLVED** that the Monterey County Board of Supervisors hereby authorizes the Director of Health or designee to enter into a financial assistance agreement with the State Water Board for the Water Beach Safety Program's Waste Discharge Permit Fund and the Beaches Environmental Assessment and Coastal Health Act Grant Program; and

**BE IT FURTHER RESOLVED** that the Monterey County Board of Supervisors hereby authorizes the Director of Health or designee to execute any financing agreements, amendments, invoices, or any other documents related to or required for the administration of said agreements; and
