Adopt a resolution honoring **Betty Jean Stallings** as a Monterey County Military and Veterans Affairs Advisory Commission's Veteran of the Year for 2021

**WHEREAS**, each year the County of Monterey and the Monterey County Veterans Services Advisory Commission honors those who have made a significant contribution to their communities, are strong motivators, have demonstrated extraordinary professional competence and are role models for veterans and the community as a whole; and

**WHEREAS**, the Monterey County Military and Veterans Services Advisory Commission is honored to recognize **Betty Jean Stallings** as a 2021 *Veteran of the Year*; and

**WHEREAS**, **Betty Jean Stallings** served in the United States Army from 1963 to 1984; and

**WHEREAS**, **Betty Jean Stallings** graduated Stanford University with a Bachelor of Science degree in 1957 and was commissioned as First Lieutenant U.S. Army in 1963. Her career included grades to Lieutenant Colonel; and

**WHEREAS**, **Betty Jean Stallings** served as Director of Logistics, U.S. Women's Army Corps Center and School. She also served at the Pentagon, in Europe and Australia and as Assistant Inspector General for the Department of Defense in Alameda, California; and

**WHEREAS**, **Betty Jean Stallings** has had leadership roles in many organizations on the Monterey Peninsula including the YWCA, Community Thrift shop, League of Women Voters, Business and Professional Women's organization and the Toastmistress Club as well as spending years serving in leadership roles in the National Parliamentarian Association, American Society Military Comptrollers and Question Managers Officers Association; and

**WHEREAS**, for many years, **Betty Jean Stallings** has played a significant role with United Way Monterey County. **Betty Jean Stallings'** work with UWMC allowed her to dedicate herself to a variety of charitable activities and perfect her skills as a parliamentarian. UWMC was fortunate to attract her philanthropic support and for more than 12 years she has quietly championed a network of human services which make a difference every day in our community.
